# Arcadia University's Graduate Program in Counseling Annual Survey of Training Sites for the 2022-23 Academic Year

### **Description of Assessment**

Each year, the Graduate Program in Counseling (GPC) surveys all direct supervisors of current practicum and internship students. This survey is intended to assess the GPC's effectiveness in meeting its programmatic mission and objectives and preparing students for their external clinical training and later employment in the counseling field. This survey was developed by the GPC's core faculty and reviewed by the Master of Psychology and Counseling Accreditation Council (MPCAC) during the program's most recent reaccreditation cycle.

## **Summary of Findings**

In total, six site supervisors completed this survey during the Spring 2023 semester. First, compared to last year's findings, it appears that the revisions made to this survey were appreciated in that no respondents voiced concerns about the survey or offered any suggestions for improvement. Overall, the results indicate that external training sites had a positive experience working with the GPC and that the GPC was generally effective in meeting its programmatic mission and objectives and preparing students for their external clinical training and later employment in the counseling field. Site supervisors appreciated our program's commitment to ethical practices, counseling techniques and theories, rapport building, trauma-informed care, and diagnostic methods. Several areas for improvement were also suggested for our curriculum, including additional training in professional behavior, clinical documentation, and person-of-the-therapist model. In addition, one respondent indicated that graduates could be better prepared for the field in terms of multiple business and legal aspects of counseling.

### **Planning & Modifications**

Based on the results of this evaluation:

- 1. When the core faculty reconvene for the Fall 2023 semester, they will discuss various ways to better prepare practicum and internship students to demonstrate professional behavior. Modifications could be made to the Fall Orientation for new students, PY570 (Professional Issues of Counseling), Practicum and Internship Workshops, and Practicum (PY587) and Internship (PY630 & PY631) Seminars.
- 2. Since clinical documentation policies and procedures vary so widely across external training sites, the core faculty do not plan to make any immediate modifications to address this comment. However, during the Fall 2023 semester, the core faculty will discuss whether our education and training in clinical documentation could be improved in terms of teaching general principles (rather than any specific models).
- 3. The core faculty believe that the person-of-the-therapist model is covered extensively within our comprehensive multicultural curriculum, which includes labs specifically designed to promote awareness and reduce blind spots. Given students' consistently positive feedback about these labs and about our multicultural training in general, the core faculty do not plan to make any immediate modifications to address this comment.
- 4. The core faculty agree that the GPC could better graduates regarding some business and legal aspects of counseling. Similar to clinical documentation, relevant business and legal information varies widely across different clinical settings (e.g., community agencies,

specialized health clinics, schools/colleges, hospitals, private practices, etc.). Accordingly, the core faculty need time to thoughtfully consider what information could be provided and where this information could be delivered within our curriculum. This will likely be a long-term project; thus, no immediate changes are likely to occur for the next academic year.
